SUBJECT MATTER/PURPOSE:

1. "Given the dire financial position the CRC faces with record declining fundraising, shall the CRC suspend the \$2.4 million in spending authority adopted by Chairwoman Brita Horn while furloughing all personnel compensation and benefits until the CRC fundraises 4 months' worth of total expenses as defined by Chairwoman Horn's previously adopted \$2.4 million spending plan?"
2. Bylaw Adoption: Strike and remove all bylaw language that allow online meetings for conducting CRC business, except for State Executive Committee meetings, and add the following to the CRC Bylaws, Article VII: *"No CRC meetings, where a vote of the CRC membership is required to conduct business, except for State Executive Committee meetings, shall be held solely online or electronically. Hybrid meetings are permitted without the use of proxies."*
3. "Shall Chairwoman Brita Horn, including all other CRC officers and appointed staff and legal counsel, cease all legal action, and their divisive attempts to recover attorneys fees and pursue sanctions, against those who asked the court to intervene in El Paso District Court Case: **2025CV30292**?"
4. "Does the membership of the CRC have confidence in the continued leadership of Brita Horn?"
